## CONNECT AND EXPAND YOUR CHURCH ON THE GO WITH CHURCHHUB™

**MANAGING A CHURCH IS NO EASY TASK. OFTENTIMES, ORGANIZATIONS OPERATE WITH A SMALL STAFF ON A TIGHT BUDGET AND ARE EXPECTED TO ACCOMPLISH DAY-TO-DAY TASKS WHILE ALSO COMPLETING REGULAR MINISTRY DUTIES. At a minimum, this app allows the church to always be connected with current and potential members anytime, anywhere. But more specifically, churches that use the app can:

- Promote and allow people to register for church events;
- Share staff bios and contact information; and
- Link to an existing blog or create a new one.

ChurchHub is available on both Android and Apple devices, and includes a content management system allowing organizations to customize the app. Churches can incorporate their own branding and images, and easily add, remove and update content at any time.

Despite all of the capabilities of the app, it is easy to use and manage, and requires very little technical skill. Additionally, ChurchHub is affordable. For GuideOne church customers, the normal \$999 setup fee is waived, and the monthly fee is reduced from \$139 to \$49. There is no limit to the number of users who

can download and use the app with the church. And, as an added bonus, the first 100 churches to sign up will receive three months of ChurchHub for free.

## HANDLING PROTESTS AT CHURCH

**AS A CHURCH LEADER, IT IS VERY IMPORTANT FOR YOU TO STAY TRUE TO THE PRINCIPLES AND DOCTRINE OF YOUR MINISTRY.** However, this can sometimes put your church and its members at odds with activist organizations, which can potentially lead to protests. While there is no secure way to prevent a protest, there are tips and suggestions for how to prepare for and handle a protest at your place of worship:

1. Understand your rights and learn about local laws concerning private property and trespassing.
2. Consult with police to utilize law enforcement and their experience to your advantage.
3. Prepare the property and inspect the area where protestors will be permitted to demonstrate. Make sure there are no hazards and post warning signs where necessary.
4. Record the condition of the protest area before individuals arrive.
5. Prepare your staff and congregation members and see that all important information is communicated to them.
6. Prepare with prayer, as it can be a helpful outlook when dealing with the situation.
7. Use a "buffer," or a well-recognized, well-trained staff person, between protestors and passing membership.
8. Respond with restraint and grace by ignoring protests and avoiding engagement in conversation or confrontation with protest groups.

Protests are never an easy situation for any organization. Consider these tips if your church is ever facing opposition with activist groups, and take steps to see that the event is as peaceful as possible. ■
